

NOTICE TO BIDDERS

Sealed bids will be received by the Burt County Clerk until December 12, 2017 at 9:00 a.m., for the construction of a concrete box culvert and other related incidental work. Bids will be opened at 9:00 a.m. and presented to the Board for consideration. The project is located on Road 45 between C Road and D Road in Burt County, Nebraska.

The project is referred to as "Tekamah Southeast, C001104505" and shall include all labor, materials, transportation and equipment required for the construction of a Triple 14'x14'x56' Concrete Box Culvert on a 0 degree skew, and other related incidental work.

Copies of the Bid Documents and Specifications are open to public inspection at the office of the Burt County Highway Superintendent, Tekamah, Nebraska. All Bid Proposals must be submitted on the forms furnished with the Bid Documents.

The sealed bids may be mailed or delivered to the County Clerk of Burt County, Burt County Courthouse, 111 N. 13th Street Tekamah, Nebraska 68061, and should be plainly marked as, "Construction Bid Proposal – Tekamah Southeast, C001104505".

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check made payable to the County Treasurer of Burt County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to provide a Start of Construction date and an End of Construction date with their Bid Proposal. The desired completion is June 1, 2018. The successful bidder (i.e. Contractor) will be allowed eighty five (85) calendar days for completion after beginning work at the site provided they do not exceed their specified completion date. Additional days due to weather may be granted at the discretion of the Engineer.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to the acceptance by the Burt County Board of Supervisors.

Burt County, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C. 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Dept of Transportation, Subtitle A, Office of Secretary, Part 21, Nondiscrimination in Federally assisted programs of the Dept of Transportation issued pursuant to such Act, hereby notifies all bidden that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin, sex, age and disability/handicap in consideration for award.

The Burt County Board of Supervisors reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the Contract will be in accordance with the County Purchasing Act's competitive bidding considerations as set forth in Neb.Rev.Stat. §§ 23-3110 to 23-3114.
