Cecil reported that the road committee discussed fixing the Mack Dump Truck. They're hopeful that estimates of \$20,000.00- \$24,000.00 will get it to operational condition.

*Courthouse Updates:* It does not look likely to get the exterior doors project off the ground in this FY. Carpet has been laid in the Veterans/DMV room. Veterans Service Office has relocated to the East side of the room, and June 19<sup>th</sup> is the tentative date for DMV relocation. A door was installed in the 3<sup>rd</sup> floor South hallway.

An open house for the **Courthouse Building's 100<sup>th</sup> Birthday** will take place (*tomorrow*) June 14, 2017 from 8:00 a.m. to 6:00 p.m. with free ice cream being offered to the public. Historical articles about the Courthouse will be displayed on the first floor, Pamphlets about the mural that is painted on the 2<sup>nd</sup> floor were made, and the beautiful courtroom will be the focus of the 3<sup>rd</sup> floor.

There being no further business to come before the Board at this time, the meeting adjourned at 11:00 A.M. until 9:00 A.M., June 29, 2017.
