Minutes of the Burt County Board of Supervisors December 27, 2017

The Burt County Board of Supervisors met in regular session on Wednesday, December 27, 2017 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Oakland Independent, upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: Cliff Morrow, David Schold, Greg Brummond, Paul Richards, Bird Swanson, Ted Connealy and Gerald Newill.

The meeting opened at 9:00 A.M. upon motion by Newill, seconded by Schold, with roll call as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Chairman Morrow informed the public that the Nebraska Open Meeting Act was posted on the wall.

The agenda was approved, upon motion by Connealy, seconded by Schold, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

The minutes of the last meeting were approved upon motion by Richards, seconded by Connealy, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

The claims for December in the amount of \$448,057.48 including \$121,746.92 for payroll, were read, audited, warrant drawn and checks generated on the respective funds, on motion by Schold, seconded by Brummond, with the exception of a claim for \$225.00 to Mainelli Wagner for the Decatur Village Bridge (M0700A3305) that was pulled and not approved. Roll call vote followed: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays- None. \$42,000.00 of the total claims reflects a transfer from the General Fund to the Road Fund. The Mainelli Wagner invoice for \$225.00 for the above mentioned bridge will be returned with a request to bill the Village of Decatur.

Don Neary offered his services for **Burt County Bridge Inspections** for 2018. Currently Dale Huffman is planning to become certified to do Bridge Inspections for Burt County, but Don's services are needed until then. Don agreed to do a 2 year contract at the rate of \$5600.00 per year, and he offered to work with Dale the second year. A contract will be drawn up and signed at the Jan. 9, 2018 meeting.

Board Member Swanson offered the following resolution and moved for its adoption: **RESOLUTION #2017-23**

WHEREAS, pursuant to NRS 32-904, polling places representing different precincts may be combined when potential sites cannot be found, contracts cannot be obtained, or site is not handicapped accessible; or, pursuant to 32-906, when there is no structure within the precinct suitable for use as a polling place the County Clerk may designate a polling place outside the precinct.

Board Member Newill seconded the motion, and the Chairman declared it adopted, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays – none.

Upon motion by Newill, seconded by Connealy, the Board went into *Executive Session* with Co. Attorney Frank Barron at 10:27 A.M. to discuss pending litigations brought against the County, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays –none. Upon motion by Schold, seconded by





Brummond, the Board went back into Regular Session at 10:36 A.M., with roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays –none. No action was taken.

The board discussed and decide on the numbers for the upcoming Salary Resolution per §23-1114. The resolution will be passed at the Jan. 9, 2018 meeting.

ROADS:

Burt County has been checking into a strip of land in Craig that allows **access to the Craig County Shed**; Frank has looked into this and reported that the Village does own this piece of property, and has agreed to deed it over to the County. Frank explained that once the County gets the deed, the board can use the property however they choose. The board agreed that they'd like to see it used in conjunction with adjoining County property to build a new access road to the County Shed.

Chairman Morrow signed a **contract** with A&R Construction (Plainview, NE) **for Bridge #1** (at Co.Rd. 45) upon motion by Brummond, seconded by Schold, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays – none. The bid was opened and accepted at the Dec. 12, 2017 meeting.

It is time for discussions of **trading in 3 CAT motor graders**. State Bids were received from Nebraska Machinery. The board asked Andy Braniff and Dale Huffman if they needed 3 new motor graders, or if they felt a new loader would be better at this point. Dale felt they didn't want to cut down the motor grader fleet this time around, but in the future it would be beneficial to get the loaders replaced. The board listened and agreed to replace all 3 motor graders. They felt that the State bids made it cost effective to do full trade ins for new CAT equipment.

Swanson made a motion to purchase 3 new CAT motor graders, one having larger wheels for the bottom, Newill seconded, roll call vote followed: Ayes – Swanson, Connealy, Newill, Richards, Schold and Morrow. Nays – Brummond. Brummond stated that he felt the current graders didn't reflect enough hours to suffice 3 new, and he would rather see 2 graders and 1 loader be purchased at this time.

A problem was found with the **Decatur Village bridge (M0700A3305)** during work that was approved at the Dec. 12, 2017 meeting. The problem proved large enough that it deemed necessary to close the bridge, and it was discovered that the repairs will exceed the \$14,000.00 previously approved by the County. The Village of Decatur was notified of the problem.

The board was given a handout to review for road projects *for the (2018) One and Six Year Road Plan.* Discussions will be held at meetings in January 2018. The public hearing for the one and six year Road Plan will be held January 26, 2018.





There being no further business to come before the Board at this time, the meeting adjourned at 12:47 P.M. upon motions by Newill and Brummond. Next meeting will be 9:00 A.M., January 9, 2018.
