HOW AND WHEN TO ENROLL

Total registration for the Traffic Program **MUST BE COMPLETED WITHIN TEN (10) WORKING days*** after the receipt of the citation or you will be ineligible and need to pay the citation.

**Total registration includes having the completed paperwork to Traffic Safety Plus within the 10 working days.*

2. *PAPERWORK TO SEND

Fee, Citation, Copy of Drivers License, , Daytime Phone Number and all other information that is directed by Traffic Safety Plus

**This information needs to be in our office within the 10 working days. No excuses.*

3. COMPLETION OF CLASS

You must complete the program within **45 days** after receipt of the citation. Charges will be filed in court pending completion of the program and dismissed upon satisfactory proof of completion.

YOU ARE ELIGIBLE

If your Burt County citation was for:

- Speeding (not more than 19 m.p.h over speed limit)
- Disregarding traffic signs and signals
- Failure to yield the right-of-way
- Wrong way, wrong side or improper passing
- Following too closely
- Improper turns, backing or lane changes
- Negligent/Careless Driving
- Not wearing a seatbelt
- No valid registration in vehicle
- No valid drivers license on person

**If you have NOT Participated in Defensive Driving Course or ADD Course in the last 3 years.*

YOU ARE NOT ELIGIBLE

If your citation was for:

- Parking Citations
- Exhibition of acceleration
- Driving too fast for conditions
- If your citation resulted from an accident
- Major traffic citations (leaving the scene of an accident , driving under the influence of alcohol and/or drugs, willful reckless or reckless driving)
- CDL Operator's License Holder
- Construction and school zone citations

The County Attorney has the right to refuse or accept any individual
