Sealed bids will be received at the office of the Burt County Clerk until September 28, 2021 at 9:30 a.m. and opened shortly thereafter, for the construction of two stream rehabilitation projects and a corrugated metal pipe with steel headwalls and wingwalls. The projects are located as follows: Site 200– on Co. Road 45 between Co. Road C and Co. Road D, Site 208 – on Co. Road 29 between Co. Road K and Co. Road L, C-11(425) – on Road H between Road 25 and Highway 32, all in Burt County, Nebraska.

The project is referred to as "Burt County EWP Sites 200 and 208 and Craig East, C-11(425)" and shall include all labor, materials, transportation, and equipment required for channel shaping, approximately 3,911 tons of rock riprap placement, steel sheet pile installation, twin 120"x70" corrugated metal pipes on a 20 deg. Skew (LHB) with steel headwalls and wingwalls, and related incidental work.

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check made payable to the County Treasurer of Burt County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. The required completion date for the EWP site 200 and 208 is December 7, 2021. The desired complete date for C-11(425) is May 1, 2022. The successful bidder (i.e. Contractor) will be allowed: fifty (50) calendar days for site 200, twenty-one (21) calendar days for site 208 and fifty (50) calendar days for C-11(425), after beginning work at that site. Additional days due to weather may be granted at the discretion of the engineer.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to acceptance by the Burt County Board of Supervisors.
