The Burt County Board of Supervisors met in regular session on Friday, September 28, 2018 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. The minutes of the previous meeting were approved upon motion by Schold, seconded by Connealy, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays – none.

Communications: The 2018 Burt County Fair's Financial Report and the 2018-2019 Fair Budget were reviewed and placed on file.

Ryan Feltz came before the board to discuss County Roads 25 & K. His concern was the conditions of Co.Rd. 25 from K-L, and of Co.Rd. K from 24-25. He is requesting Co.Rd. 25 be closed, (or at least maintained) and he would like to see some maintenance on Co.Rd. K. Ray Petersen spoke on behalf of Silvercreek Township concerning Co.Rd. 25, he said the Township is willing to do whatever the County Board would like to see done with the road. Brett Johnson and John Wilson both own ground in the area along Co.Rd. K, and they expressed that they don't want to see Co.Rd. K closed. The County Board agreed to leave both roads open; they'll discuss road maintenance with the townships; Silvercreek (Co.Rd.25) and Summit (Co.Rd. K).

The **annual Delinquent Tax List** (dated 9/25/2018) prepared by County Treasurer Robin Olson was noted and placed on file. Frank Barron, Burt Co Attorney will review for possible future foreclosures the County may proceed with.

Ryan Poots, with EagleView came to present a contract and to answer any further questions they may have from his 9/11/2018 **Pictometry** presentation. Mr. Poots explained that the project will need a contract approval in order to start laying out the timeline. The board did not take any action today.

The board approved to have Clerk Sarah Freidel schedule the project for **Board Minutes to be made** *electronic*, *searchable documents*. This was first discussed in May 2018; a company and favorable cost for the project has been located: Microfilm Imaging Systems, Inc. ~\$1,400.00 for scanning 9 books and the purchase of the programming.

**Certification of Cost Allocation Plan from Maximus** was reviewed and signed upon motion by Connealy, seconded by Schold, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

Roads: Due to the **unexpected resignation** of Cecil Brummond, the Burt County Highway Superintendent/Zoning Administrator, the County Board voted to do an emergency temporary hiring in order to keep up on the roads paperwork (invoices, payroll, zoning). Schold made a motion to hire Ann Chytka, motion was seconded by Swanson, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none. Employment ad(s) for the open position will run the month of





October.

Gerald Newill and Paul Richards discussed NACO Northeast District meeting information about the Federal Bridge Fund Program, applications and dates.

There being no further business to come before the Board at this time, the meeting adjourned at 12:00 P.M. upon motions by Connealy and Schold. Next meeting: October 9, 2018 at 9:00 A.M.
