The Burt County Board of Supervisors met in regular session on Wednesday, November 28, 2018 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Plaindealer, upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: Cliff Morrow, David Schold, Greg Brummond, Paul Richards, Bird Swanson, Ted Connealy and Gerald Newill.

The meeting opened at 9:00 A.M. upon motion by Newill, seconded by Schold, with roll call as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none. Chairman Morrow informed the public that the Nebraska Open Meeting Act was posted on the wall.

The minutes of the last meeting were approved upon motion by Schold, seconded by Connealy, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays – none.

Chairman Morrow signed a **lot split application** for: (1) MARY BRADER 4.04 acres located in part of the SE¹/₄ NE¹/₄ of Section 4, Township 20 North, Range 9 East of the 6th P.M., Burt County, Nebraska.

Students from Tekamah-Herman High School's Close Up Group (Payton Pruess, Sydney Brummond and Mylee Sheets, sponsor: Karin Pruess) came before the board to follow up with the County Board's request to contact other schools to get involved in their fundraiser selling engraved bricks to commemorate Veterans. They reported that they had reached out to the other Burt County Schools, and had no one wanting to join their efforts at this time; Lyons-Decatur reported they had no kids going on the Close Up trip and Oakland-Craig did not respond per their request by this time. The girls asked for the board's support to go ahead with the sales. Sales will begin, and the group will return in April to put together a plan with the Board for installation of the **Bricks on the Courthouse grounds**.


Patty Plugge presented an application for consideration for a **Commercial Building Rehab Grant**. Plugge reported that the Burt County Economic Development Board has reviewed the project and recommended their approval for the application. The application is from Aleta Jessen & Ruvan King, for a roof on 2 (side by side) buildings and a fascia project for Barney's BarSalon in Decatur. According to the language of the grant, monies are awarded for up to 50% cost of 2 low bids. The Burt County Board approved the release of \$3,000.00 for roof and \$4,946.00 for fascia; funds will be released from County Fund 0900 upon completion of the project(s). Approval was upon motion by Brummond, seconded by Connealy, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

Upon motion by Swanson, seconded by Brummond, **the 2019 Board meeting dates were approved**, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

The Board acknowledged and agreed that according to the rotation that has been in place for some time, **the Lyons Mirror-Sun will be the main paper used in 2019** for legal publications.

The board signed a **Memo of Understanding with Madison Co Atty Office- for NE Crime Commission's 2019 Community Based Juvenile Services Grant**; approved upon motion by Connealy, seconded by Newill, with roll call vote as follows: Ayes – Morrow, Schold, Brummond, Richards, Swanson, Connealy and Newill. Nays – none.

Upon motion by Swanson, seconded by Schold, the Board went into *Closed Session* for the protection of the public interest to discuss pending litigations with County Attorney Frank Barron, roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays – none. Chairman declared the meeting entered into





closed session at 11:01 A.M. Board members Brummond and Newill moved the Board come out of closed Session, roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays –none. Chairman declared the meeting was back into regular session at 11:10 A.M. No action was taken during closed session.

ROADS:

Highway Superintendent/Zoning Job Openings: The road committee held interviews with four applicants for the positions. They'd reported that one applicant withdrew. Schold made a motion to form a selection committee to sit down with the applicants for second interviews, motion was seconded by Connealy and approved with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none. The selection committee made up of Richards, Swanson and Morrow will hold a second round of interview(s) before the next meeting.

There being no further business to come before the Board at this time, the meeting adjourned at 11:17 A.M. upon motions by Connealy and Newill. Next meeting will be December 11, 2018 at 9:00 A.M.
