Minutes of the Burt County Board of Supervisors December 28, 2018

The Burt County Board of Supervisors met in regular session on Friday, December 28, 2018 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Plaindealer, upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: Cliff Morrow, David Schold, Greg Brummond, Paul Richards, Bird Swanson, Ted Connealy and Gerald Newill.

The meeting opened at 9:00 A.M. upon motion by Newill, seconded by Schold, with roll call as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none. Chairman Morrow informed the public that the Nebraska Open Meeting Act was posted on the wall.

Upon motion by Connealy, seconded by Newill, the agenda was amended to add Resolution 2018-20; upon motion by Schold, seconded by Connealy, the amended agenda was approved, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

The following claims for December in the amount of \$428,845.51, including \$130,424.62 for payroll, were read, audited, warrant drawn and checks generated on the respective funds on motion by Schold, seconded by Connealy, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Connealy, Newill and Morrow. Nays – Swanson. \$28,000.00 of this total reflects a transfer from the General Fund to the Road Fund.

The minutes of the last meeting were approved upon motion by Schold, seconded by Newill, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays – none.

Allen Soll shared a full copy of the aeronautical study referenced in Communication (1).

Rex Sears came to the board to ask for funding for **lunches for County Government Day**. He explained that the NE Natl. Guard used to fund this, but has announced that 2018 was the last year they'd do so. Sears asked the County Board if the lunch costs could be covered by the County Funds. The Board approved the request and made a motion to budget and pay for lunches for this program on a permanent basis, motion was made by Schold, seconded by Richards, with roll call vote as follows: Ayes - Ayes -Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

Upon motion by Brummond, seconded by Richards, the Board authorized Chairman Morrow to **sign the 2018 Certification(s) of County Highway Superintendent**, with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays – none.

Bonds for the 2019-2022 terms for the Burt County Elected Officials were discussed; position bonds will be issued for Attorney, Assessor, Roads, Sheriff, Surveyor, Supervisors and Weeds (\$5,000. each position), and other type of bonds to be purchased will be individual position bonds on Treasurer, County Clerk, and District Court Clerk (\$100,000. Each position).

Board Member Brummond seconded the motion, and Chairman declared it adopted, with roll call vote as follows: Ayes – Schold, Brummond, Richards, Connealy, Newill and





Morrow. Nays - Swanson.

Pay for the Zoning Position was discussed: There has not been a zoning/floodplain administrator on staff for the County since September 2018; Sarah Freidel, Burt County Clerk has had to take on the duties of that office. Brummond made a motion to pay Freidel \$250.00/mth for 4 months (Sept.-Dec. 2018), Schold seconded and motion passed with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.

ROADS:

- County Road F (access road @ Summit Lake Area): Scott Herbolsheimer came before the board to opposed closing of this road. He explained that he purchased his property in 1994, and at that time the road had been being maintained; since then a gate has been put up across the road by NE Game & Parks, whom lease the land from Papio-Missouri NRD, and maintenance has not been done on this road. Herbolsheimer explained that this is the last remaining access on the South end of the lake, and he feels it's important to give the public this access. The Burt County board looked into the status of this road after discussions with Ian Maslowsky at their 12/11/2018 meeting; the only information found was in 1978 Summit TWP had permission to abandon and relocate the road (MISC. bk.29 p.674-679), but no action had ever been taken by the County Board to close the road. It is the opinion of the Burt County Board that (because the road is a township road) Summit TWP, the NRD, and Game and Parks will have to work together to come up with a plan for the road. If need, the Township would bring any further requests/concerns with the road back to the County Board.
- Highway Superintendent/Zoning Job Openings: The road committee recommended offering Ann Chytka the Highway Superintendent position with hourly pay of \$23.50/hr., with a \$2.00/hr. raise after she obtains a Class B License and another \$2.00/hr. raise after she obtains a Class A License; motion was made by Schold, seconded by Connealy to go ahead with the offer, motions were approved with roll call vote as follows: Ayes –Schold, Brummond, Richards, Connealy, Newill and Morrow. Nays-Swanson.

 The road committee recommended offering Ann Chytka the Zoning/Floodplain position with monthly pay of \$300.00/mth., until they can find an individual to take the position permanently; motion was made by Schold, seconded by Brummond to go ahead with the offer, motions were approved with roll call vote as follows: Ayes –Schold, Brummond, Richards, Swanson, Connealy, Newill and Morrow. Nays-none.
- *One and Six Year Road Plans:* Allen Soll (Tekamah Airport Rep) came before the board to request the board's consideration for a hard surfaced road going out to the airport. The new road employee will be drafting a working copy of the new plans to be reviewed at the next meeting. The board reviewed last years completed projects, and explained that they're considering fulfilling the request with the use of millings from Co.Rd. GH project that they know is high on the 2019 list of projects.
- Dale Huffman made mention to the board that in the near future the roads department will need to do some hiring, they are down 2 road employees.





There being no further business to come before the Board at this time, the meeting adjourned at 11:53 A.M. upon motions by Connealy and Newill. Next meeting: January 8, 2019 at 9:00 A.M.
