The Burt County Board of Supervisors met in regular session on Monday, January 28, 2019 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Communication received: A letter addressed to the Board from Marvin M. Andersen regarding a concern of an abandoned cemetery (South Argo). The board discussed and





decided that Carl Pearson will answer the concerns since the cemetery is in his district.

Richards moved the Board recess at 9:45 AM for *Board of Equalization*, Connealy seconded, with roll call vote as follows: Ayes – Morrow, Richards, Pearson, Webster, Connealy and Schold. Nays –none. Absent -Swanson. The Burt County Board of Supervisors reconvened at 10:01 AM upon motion by Connealy, seconded by Pearson, with roll call vote as follows: Ayes – Morrow, Richards, Pearson, Webster, Connealy and Schold. Nays –none. Absent -Swanson.

Board Members Connealy and Morrow moved for adoption of:

RESOLUTION #2019-02

"WHEREAS, the State of Nebraska requires Burt County to prepare and submit a One- and Six- Year Plan for Highway Improvement and SSAR (Standardized System of Annual Reporting) reports and;

"WHEREAS, the appropriate forms need to be prepared and signed by a qualified and authorized person:

THEREFORE, let it be resolved that the Burt County Board of Supervisors herein authorize the Chairman of the Burt County Board to prepare and sign the Burt County One and Six Year and SSAR documents for 2019."

Terry Schroeder, **Burt County Emergency Manager** informed the Board that he has been reviewing all that needs brought up to date for Burt County Emergency Management, and has decided that he does not want to continue into the Full Time position. He explained there is a lot to do and he wants the Board to hire someone else (full-time) for this position; he explained that the State required Counties to employ an Emergency Manager at a full-time status and there are funds (grants) that can help offset the expense. Terry agreed to stay on part-time until someone could be hired. Terry reminded the Board that the LEOP will need updated in 2020. The board thanked Terry for his service, told him they were saddened to hear of his decision, but they understand.

Carl Pearson shared an invitation from Craig Township to attend a meeting they have scheduled in an effort to help educate/inform new Township members. They are hoping to get several old and new Township Board Members together to help navigate what the newly activated boards need to know/understand. The meeting is scheduled for Feb. 6, 2019 @ 7:00 p.m. at the Craig Fire Hall. Dave Schold made mention that some townships have asked for gravel allocations from the County to be increased, the County may be able to consider the increase when it comes time for the new budget year.

Upon motion by Connealy, seconded by Webster, the Board authorized Chairman Schold to sign the 2018 Burt County Weed Control Authority Activities and





Information Report, with roll call vote as follows: Ayes – Morrow, Richards, Pearson, Webster, Connealy and Schold. Nays – none. Absent -Swanson.

The Weeds office is going to be moved from the 1st floor meeting room into the copier/postage area to give Tory his own work space and to free up the meeting room.

Motion was made by Connealy, seconded by Webster, to appoint Carl Pearson (elected official) and Patty Plugge (non-elected official) as Burt County's **representatives for NENEDD**, with roll call vote as follows: Ayes – Morrow, Richards, Pearson, Webster, Connealy and Schold. Nays – none. Absent -Swanson.

Patty Plugge presented applications (2) for consideration for **Commercial Building Rehab Grants**. Plugge reported that the Burt County Economic Development Board has reviewed the projects and recommended their approval for the applications. The applications are from: (1) Fallout Bar (Lyons) for fascia repairs; \$7,845.00 would be 50%, but could go up if further problems are found. (2) KB's Mini Mart (Lyons) for a new awning, lighting, concrete across the front of the building; \$15,000.00. The Burt County Board approved the release of said funds from County Fund 0900 upon completion of the project(s). Approval was upon motion by Connealy, seconded by Richards, with roll call vote as follows: Ayes –Morrow, Richards, Pearson, Webster, Connealy and Schold. Nays-none. Absent – Swanson.

The building and grounds probationary period is up for Bruce Nathan, since the board oversees this position, they discussed a positive work performance evaluation and approved a pay raise to return the position to the previous pay grade. Upon motion by Morrow, seconded by Webster, the Board set the hourly rate at \$18.76, the rate was approved with roll call vote as follows: Ayes – Morrow, Richards, Pearson and Webster. Nays - Connealy and Schold. Absent -Swanson.

The Board approved (on 1/8/2019) a **cost of living** increase of 2.5%, but **clarification** is needed after reviewing the Elected Officials' salaries per Resolution 2018-02. Upon motion by Connealy, seconded by Richards, the board clarified that the c.o.l. raise to be applied January 2019 payperiod is 2.5%, with the exceptions of: the Highway Superintendent/Zoning will be 0%, the hourly wage shall remain (\$23.50) which was set upon her hiring Dec. 2018; the Elected Officials noted on Resolution 2018-02 will receive 0.5% plus the salary amount from Resolution 2018-02. This motion/clarification was passed with roll call vote as: Ayes – Morrow, Richards, Pearson, Webster, Connealy and Schold. Nays – none. Absent – Swanson.

Roads: The Board reviewed possible projects for the One and Six Year Road Plan with Highway Superintendent Ann Chytka, Burt County Road Foreman Dale Huffman and Jeff Wagner from Mainelli Wagner. The public hearing will be held February 12, 2019.

Paul Potadle asked to address the board with some opinions/concerns about consideration of hard surfacing Co.Rd. 41 (North and South, between GH & G) to the airport: (1) He feels that the direction is out of the way, anyone leaving the airport and heading South back out of town will not want to go back North before hitting town to drive





South again. (2) This route also causes concerns with (foot traffic) school students going back and forth between the school buildings at the intersection in town where said traffic would be directed to turn back South onto Hwy. 75. (3) The base of that road is not a solid base to build on.

A draft for a bid notice for Co.Rd. GH overlay was reviewed and approved by the Board. Ann will run the ad and bids will be open Feb. 12, 2019 @ 10:00 A.M.

Coughlin Company representatives Ron Matteson and Ryan Weber gave a presentation on some of the services they provide, i.e. Cold In Place Recycle, Full Depth Reclamation, etc. They asked the board to consider some of their services when/if they have any asphaltic overlay projects in the future.

Road committee meeting times were discussed, possibilities for moving the meeting time up, holding separate meetings for roads only, etc. The board decided to leave meetings the same at this point.

There being no further business to come before the Board at this time, the meeting adjourned upon motions by Connealy and Richards at 12:40 P.M. Next Meeting: February 12, 2019 @ 9:00 A.M.
