



Terry Schroeder, **Burt County Emergency Manager** reminded the Board that the State requires Counties to employ an Emergency Manager at a full-time status in order to receive salary reimbursement funds for the position. The board would like to clarify funding requirements for wage reimbursements and FEMA programs; they want to visit with Bryan Tuma from Nebraska Emergency Management Agency. They'll revisit the position after they get more questions answered. Terry Schroeder reported that a storm spotter class has been set up for April 15, 2019 at the Lyons Fire Hall.

Burt County will receive Insurance bids for P&C Insurance this year (2019). The insurance specs will be available in March, we'll be asking for 3 year proposals. Notice will be given for sealed bids: Bids are to be received by April 2, 2019. Bids will be open at April 9, 2019 meeting. Newspaper Publications will run: March 12, 19 & 26.

Roads:





The board discussed how to help the newly activated Townships figure out how to budget; they feel they need to come up with some starting numbers so that the townships have a direction when they go to build their first budgets. Road department will review costs of signs, miles of roads and inventory of signs out on the roads. Paul Richards suggested an outline that can be used as a starting budget worksheet for the townships; he volunteered to provide assistance to any of the townships that would like help.

The banks at the #1 Bridge are sluffing off; Dale Huffman will discuss options with Jeff Wagner, Mainelli Wagner Engineering.

Ann reported that Julie Hayes, a resident from Harbor 671 told her that previous Highway Superintendent had told them that they could buy millings from Co.Rd. GH project; she needed clarification from the Board after this phone call. It was agreed project contractors will have say over what happens to any millings that come from said projects they are working on.

Roads equipment fleet was discussed; how many blades are needed vs the needs of payloaders, etc. It was agreed upon that no decisions should be made about changes with the fleet until we know the direction of the newly reactivated townships.

The lease on the current skid loader is up next month. The county has an ongoing contract to lease a skid loader year to year; the road department will continue to secure a new lease for the coming year.

The board wanted to officially commend the Burt County Road Crews for a JOB WELL DONE during the last month with all of the snow!

Board Appointment Reports: Morrow gave a synopsis of Northstar and Region IV Services for the new board members. Richards reported on ELVPHD and an Emergency Management meeting that he and Schroeder attended in Wayne.

There being no further business to come before the Board at this time, the meeting adjourned upon motions by Connealy and Richards at 11:14 A.M. Next Meeting: March 12, 2019 @ 9:00 A.M.
