The Burt County Board of Supervisors met in regular session on Tuesday, May 11, 2021 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Plaindealer (5-4-2021), upon a 1st floor bulletin board within the courthouse and on the County’s Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: David Schold, Cliff Morrow, Gary “Bird” Swanson, Paul Richards, Carl Pearson, Dale Webster and Ted Connealy.

The meeting opened at 9:00 A.M. with the pledge of Allegiance. Chairman Schold informed the public that the Open Meeting Act is posted on the wall.

EWP Projects (for 2021)- Chytka reported that she'd gotten another round of the EWP **(Emergency Watershed Protection) Program** projects awarded through **NRCS** (Natural Resources Conservation Service) for 2021. She presented a map of the planned 2021 projects.

FEMA bond/Line of Credit – Chytka reported that her budget has the funds, and she plans to pay off the line of credit for the FEMA bond that will be due May 2021.

Culverts – This season's culvert work will be starting; culverts have been ordered.

There being no further business to come before the Board at this time, the meeting adjourned at 9:23 A.M. upon motions by Webster and Pearson.
