**Burt County Extension Office:** Angi Heller, Engagement Zone 8 Coordinator (a) 2022 Annual Report: Presented and placed on file. (b) County Supervisor Liaison: Carl Pearson volunteered. (c) Burt County Extension Board Constitution & ByLaws: Currently Burt County Extension Board is comprised of 9 members throughout 5 Districts; they would like to change their constitution & bylaws to align their districts with the 7 Burt County Supervisors districts, having 1 member from each district. (d) Extension Vehicle: The vehicle has broken down and had check engine light on, so they have not been utilizing the vehicle. After discussion with the board, Heller will check with the department to see if they will commit to using the vehicle if it gets fixed in lieu of charging mileage on their personal vehicles. Follow up will be done pertaining to vehicle use. (e) staffing (i) Angi and the board discussed when they feel it's appropriate for office manager to attending meetings, be out of office, etc. The board relayed that they want the office to be open to the public at all times, just as all other County offices are. (ii) Luan Oliveira will be leaving his position as Water & Cropping Systems Extension Educator for Burt, Thurston & Dakota Counties by July 31, 2023; there will be a future posting for the position via UNL Extension.

## Community Development Block Grant (CDBG) for Midwest Vet:

Chairman Schold signed a request for funds for Draw#5 (final draw). After the State drops the funds into Burt County, a claim will be issued as: \$2,771.37 to Northeast Nebr. Economic Development District for the final portion of \$7,000.00 grant admin fees.

Fee schedule update was discussed; consideration to add for Conditional Use Permits a 'request for 1 year extension' fee = 5% of original fees. A Resolution will be drafted for future action.
