COMMUNICATION (2): (1) opposition letters were sent to the committee and Senator Hansen regarding LB1067, Inheritance taxes phase out legislation proposal; (2) Lwr. Elkhorn municipality funding available via cost share grants, application deadline is March 14, 2024.

Public Transit (JOYRIDE):

Interlocal Agreement to collectively provide local funding for a Rural Transit Program to be operated by Franciscan Healthcare Services, Inc. for the benefit of residents of Cuming and Burt County. The funds will partially reimburse Franciscan Healthcare Services, Inc. up to 25% of operating expenses, 10% of admin expenses, and 10% of vehicle acquisition expenses incurred by the Transit Program. Agreement is effective March 1, 2024. Entities and funding involved are: Cuming County (\$20,000.00); Burt County (\$20,000.00); City of West Point (\$4,500.00); City of Tekamah (\$4,000.00); City of Oakland (\$2,500.00); City of Wisner (\$2,000.00); City of Lyons (\$2,000.00); Village of Beemer (\$1,500.00); Village of Bancroft (\$1,500.00); Village of Decatur (\$1,500.00); and Village of Craig (\$500.00). Supervisor Schold made a motion to sign the Interlocal Agreement; Kutchera seconded, motion passed By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays – none.

Boardroom Equipment:

A quote for a second tv/display monitor was approved upon motions by Kutchera and Titus. By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays – none. Black Diamond Electronics will install the tv on the North wall; project cost ~\$1,500.00.

ROADS: Ann Chytka, Hwy Supt (not present).

Leon Anderson and Kirby Bowland, present from the roads dept.

Plow Trucks: Two new trucks from Kenworth will arrive soon. The (2) trucks being replaced can either be traded in or sold on auction; the board will decide at a later date.

2014 Motor Grader (fleet #7): It was previously discussed to possibly get rid a motor grader, but the roads department does still utilize this machine enough that they'd like to keep it. The board agreed to keep it in the fleet.

Burt County Audit for FY 2022-2023:

Correspondence Received: from Mark Avery, CPA- Assistant Deputy Auditor A letter dated January 25, 2024, notifying our current Auditing firm, Ritterbush & Piotrowski, LLP, that the Nebraska Auditor of Public Accounts (APA), from this date forward, will not be accepting audit report filings from this firm because the firm has not demonstrated the desire to follow required professional standards. Due to the correspondence, Burt County must secure a new Auditing firm to complete the FY22-23 Audit. *Bids:* County Clerk, Sarah J Freidel reached out to multiple firms to request services/quotes; two firms returned quotes: Ric Ortmeier & Assoc. LLC (\$30,000.00); Contryman Assoc. (\$14,500.00- \$17,500.00).

The Board voted to hire Contryman Assoc. to complete the Audit; upon motions by Schold and Swanson. Passed By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays – none.
