The Burt County Board of Supervisors met in regular session on Wednesday, February 28, 2024 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Plaindealer (2-20-2024), upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. #### (Zoning) Update Matrix for Campgrounds:

Update Zoning for Camp Grounds (General and Group) to require a conditional use permit in ALL zoning districts; currently (A-1, A-2, R-M, C-1, and PU) a CUP is needed. Update would add (R-1, I-1, and I-2) to also require a CUP.

A PUBLIC HEARING was opened at 9:46 a.m. Speaking during public hearing: Three (3) members of the public voiced concerns about campgrounds in residential areas (1) Florence Stevenson; (2) Deanna Goodwin; (3) Jared Goodwin. Vice-Chairman Schold closed the public hearing at 9:58 a.m. Zoning Administrator, Ann Chytka reported that the Burt County Planning Commission held a hearing for this on 2/26/2024 and recommend their approval of the changes. Chytka explained that the County Board would pass a Resolution if they wanted to approve the changes.

Board Members Swanson and Pearson moved for adoption of Resolution 2024-06. The Resolution was adopted By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus and Schold. Absent- Connealy. Nays – none.

### Resolution 2024-06 A RESOLUTION UPDATING THE BURT COUNTY LAND USE MATRIX

WHEREAS, on February 26th, 2024, the Planning Commission of Burt County, Nebraska did hold a public hearing for updates made to the Burt County Land Use Matrix. By updating Camp Grounds-General and Camp Ground-Group to need a conditional use permit in all zoning districts.

WHEREAS, by updating the Burt County Land Use Matrix updates were needed in Section 4.05 R-1 Residential District, B. Permitted Conditional Uses add 7. Camp Grounds, Section 4.08 I-1 Light Industrial, B. Permitted Conditional Uses add 9. Camp Grounds, and Section 4.09 I-2 Heavy Industrial, B. Permitted Conditional Uses add 27. Camp Grounds

WHEREAS, the Burt County Board of Supervisors held a public hearing on February 28th, 2024 to consider the updates recommended by the Planning Commission for the Burt County Land Use Matrix in the Burt County Zoning Regulations.

WHEREAS, the Burt County Board of Supervisors now believes that it is in the public interest to adopt said Land Use Matrix.

NOW, THEREFORE, BE IT RESOLVED by the Burt County Board of Supervisors that:

- 1. The public hearing had advanced notice as required by Nebraska law and conformed with the Nebraska Opens Meeting Act, and Section 9.01-Amendments of the Burt County Zoning Regulations and,
- 2. Upon consideration of all matters presented to the Board, the Board of Supervisors did vote to amend the Burt County Zoning Regulations relating to Burt County Land Use Matrix and Sections 4.05,4.08, and 4.09
- 3. A copy of the amended regulation is attached hereto as Exhibit "A" and incorporated herein by reference, and,
- 4. This resolution shall be in full force and effect from and after its passage.

NEUTRAL: One (1) Kelly Adamson, Tekamah City Council Member. Seasonal campground with 55 lots initially platted and possible phase 2 and 3 in the future. Vice-Chairman Schold closed the public hearing at 11:10 a.m.
