The Burt County Board of Supervisors met in regular session on Friday, April 26, 2024 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. ### **Building and Grounds:**

Communication from Jacob Hurla, *Community Building Solutions* was shared regarding facility improvement projects for public entities. Building and Grounds Superintendent asked that the board be informed about the company and asked the board to let him know when/if they are ready to consider such enhancements to the building functionality (i.e. energy efficient upgrades, replace boiler, windows, etc).

### BURT COUNTY SOLAR update-Sandhills Energy.

Brian Borner reports the project is in its second year of a 2-year extension of the Conditional Use Permit (CUP) with Burt County. They anticipate construction to start prior to the expiration of the CUP, which will be April 2025. At this point, they are still in planning phase for distribution within the *Southwest Power Pool*. They offered to come back with updates in the Fall of 2024.

**Burt County Extension Office:** Angi Heller, Engagement Zone 8 Coordinator Rescheduled – no action.

**Zoning:** Ann Chytka, Burt County Planning & Zoning Administrator
Chytka is requesting more time to further review wind regulations, she is asking for a 90-day extension from the current 6-month extension already in place. Resolution 2024-07 was presented for consideration. Board Members Kutchera and Swanson moved for adoption of Resolution 2024-07. The Resolution was adopted By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays – none.

Resolution 2024-07 EXTENSION ON TEMPORARY MORATORIUM ON WIND ENERGY CONVERSION SYSTEMS WITHIN BURT COUNTY, NEBRASKA.

WHEREAS, the Board of Supervisors of Burt County, Nebraska (the "Board"), contemplates amendments to the existing Burt County, Nebraska, Zoning Regulations, to include provisions regulating wind energy conversion systems (WECS); and

WHEREAS, the Board desires to extend the current moratorium Resolution No. 2023-19 an additional 90 days on prohibiting the Administrator of Planning and Zoning, Planning Commission, and the Zoning Board of Adjustment, from accepting or otherwise acting on any application to develop a wind energy conversion system (WECS).

WHEREAS, the Board of Supervisors will grant the extension until September 30th 2024, or until the Board completes its review and amendment of the Regulations regulating wind energy conversion systems, whichever is earlier.

NOW THEREFORE, BE IT RESOLVED, the Board hereby approves this resolution. The moratorium described above shall be effective as of the date below and continue until September 30th 2024.

**Zoning** -Wind Survey: Chytka suggested sending a survey to all Burt County registered voters: 'Do you want wind turbines in Burt County?' 'yes/no/undecided'. The board discussed the pros and cons of doing such survey. (There was no action on the survey as it was not on the agenda.)

## Lot Split:

Chairman Connealy signed a lot split for JEFFREY ANDERSON - 4.43 ac in pt. SW<sup>4</sup> SW<sup>4</sup> in Sec.31, TWP 23N, Rge.10E, Burt County, NE.

#### **Closed Session:**

Titus made a motion to go into *Closed Session*, Kutchera seconded, and the motion passed with All Ayes. Chairman Connealy declared at 9:33 A.M. the board went into closed session *for the protection of public interest to discuss collective bargaining*. Pearson made a motion to come out of Closed Session, Schold seconded, and motion passed with All Ayes. Chairman declared the public meeting back in regular session at 9:54 A.M. No action was taken during closed session.

### Emergency Management - Jason Redding-Geu:

Jason reported on all that he has been working on since he started; he explained that there will be daily tasks recorded for anyone interested.

Vehicle/Equipment: Jason asked for permission to set up his vehicle with the Verizon GPS fleet tracking equipment (same as that the road's vehicles are fitted with); fee will be \$19.95/month. The equipment was approved by the Board; upon motions by Richards and Swanson, By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays- none.

*Cont. Ed:* Jason asked permission to take a defensive driving class. The board asked for further details: cost, location, etc.

*Certification update:* Jason is planning final coursework to be done in October 2024 for full certification.

*Grant:* The EMPG paperwork (Emergency Management Performance Grant) has all been caught-up and is now in good standing for Burt County's reimbursements.

## **Assessor – permissive exemptions:** *Katie Hart*

Katie shared that 2024 is a year of full review by the State on permissive exemption filings across all Counties. She reports that the State is asking if Burt County wants to reconsider their approval for Tekamah-Herman Wrestling Club property. Assessor's office opinion remains that the property is exempted under 'charity', and she explained that the Board has a right to change their recommendation. If the board does not change their recommendation of approval, the State can still take the decision to review via TERC action. The board will have to put on a future agenda if they want to take any different action.

## **Special Designated Liquor License:**

Nelson's Food Pride requested SDL's for (3) dates that they are serving for wedding receptions at Harvest Moon: June 8, August 3, August 31; and for a Truck Show at the Burt County Fairgrounds on August 2. Burt County Board approved the SDLs for all dates requested; upon motions by Schold and Kutchera. Approved By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Connealy and Schold. Nays – none.

## **ROADS**: Ann Chytka, Highway Superintendent

Road Employees 'summer' schedule: The Weeds and Roads department outside crews will run on a weekly schedule of four (4)- ten (10) hour days from May 6, 2024 – Aug. 30, 2024, hours being 6:00 a.m. to 4:30 p.m. Chytka explained there will be roads crew members all five (5) days a week; some will work Monday-Thursday, and some will work Tuesday-Friday. Holiday hours will be 6:00 a.m. to 2:30 p.m., in order to maintain an 8 hour work day.

PUBLIC COMMENT (3): (1) Julie Drennen, outreach manager for RWE Clean Energy-offered resources and help to connect anyone with questions/concerns for wind projects. (2) Bill Price, 1615 CoRd. 10, Lyons- shared opinion of setbacks from property lines, not from dwellings. Expressed appreciation of the board taking more time with the moratorium and expressed his favor of a county-wide survey. (3) Sue Hansen, RWE Clean Energy (Development Manager for Burt County Wind) – expressed that there are setbacks in place that address Mr. Price's concerns.

There being no further business to come before the Board at this time, the meeting adjourned upon motions by Titus and Schold at 11:12 A.M. Next Meeting: Wednesday, May 8, 2024 @ 9:00 A.M.
