The Burt County Board of Supervisors met in regular session on Wednesday, May 8, 2024 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Plaindealer (4-30-2024), upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The meeting opened at 9:00 A.M. with the pledge of Allegiance. Chairman Connealy informed the public that the Open Meeting Act is posted on the wall.

Upon motion by Titus, seconded by Kutchera, the agenda was approved. By roll call vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays – none.

(Zoning) Conditional Use Permit (CUP) application- SHOOFLY LLC: CUP to build a 625 sq ft seasonal dwelling in pt. S½ NE¾ of Sec. 23, TWP 23N, Rg.10E of sixth PM, Burt County, NE. Zoning Administrator, Ann Chytka reported that the Burt County Planning Commission approved the CUP at their 5/6/2024 meeting. A PUBLIC HEARING was held at 9:15 a.m., Daniel Marquis the property owner explained the project lies within a current 4.68 ac parcel; there was no public comment. The Burt County Board approved the CUP upon motion by Richards, seconded by Swanson. Motion Passed by Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays – none.

The board voted to accept the bid from Tim Sisco Const. for \$163,997.00, upon motion by Schold, seconded by Swanson. By Roll Call Vote: Ayes- Swanson, Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays- none. Motion passed.

Burt County Economic Development (BCEDC) Cindy Chatt, director BCEDC: (3) Grants: Chatt reported that the BCEDC board has reviewed and recommended their approval for all three of the following Private Foundation Grants: (#1) Fund 0900, Demolition Grant for James Kelly to demo a house at 1022 H St., Tekamah, this application is coming back to the board for reconsideration after three bids were turned in; \$8,750.00 (50% of the low bid); approved upon motion by Pearson, seconded by Richards. By roll call vote: Ayes - 6. Nays - Swanson. Motion passed 6-1. (#2) Fund 0900, Commercial Reno Grant for Swedish Heritage Museum (Oakland) for a new roof. One building can only receive \$15,000.00 max of Grant monies; this building has previously received Grant monies for two other projects, so the max they can receive is \$8,141.20 (which is less than 50% of the low bid). Approved upon motion by Titus, seconded by Swanson. By roll call vote: Ayes – 7. Nays – none. Motion passed. (#3) Fund 0900, Commercial Reno Grant for VFW building (Tekamah) for new roof. This building currently requires many improvements, however, the VFW organization reported that they have no choice as they have nowhere else to go; they plan to fund this new roof via this grant and donations. \$8,250.00 (50% of the low bid) was approved upon motion by Richards, seconded by Titus. By roll call vote: Ayes - 7. Nays - none. Motion passed.

Tourism Campaign: Chatt presented a Burt County Tourism marketing plan proposal; she is proposing the cost of the 3-part plan be split between BCEDC and Burt County Visitor's Promotion Fund (0990); she is still in the process of getting approval from the Tourism Board members.

County Health Insurance:

Employee Health and Dental Insurance premium options were presented for July 1, 2024 renewal date. The Board agreed to stay within NACO's group pool BCBS insurance and continue with the offering package as follows:

Health Ins with Blue Cross Blue Shield NACO (\$6,100 deductible -QHDHP)

Dental Ins with Blue Cross Blue Shield NACO (option 3)

Deductible Buy-down via Mid-American (no amount was decided today)

(12 mth.) Option for Section 125 plan with First Concord

Option for Cash-in-Lieu plan with First Concord; paying \$400 (single), \$800 (family)

Employee Pay Option for Vision Insurance with VSP

Employee Pay Options for Supplemental Life/Disability Buy-up

The board asked that Mike Boden with NACO Benefit Services come to the next meeting to review the County's buy-down usage throughout the last year. A buy-down package will be decided on and the final benefit package will be approved after those discussions on May 28, 2024.

PUBLIC COMMENT: Donette Jackson (5000 CoRd. HI)- stated she cannot hear during the meetings sometimes; she asked if the County Board would consider getting a microphone for the Boardroom.

There being no further business to come before the Board at this time, the meeting adjourned at 10:10 A.M. upon motions by Schold and Titus. Next meeting: May 28, 2024 at 9:00 A.M.
