Signing of the Year-End Certification of County Highway Superintendent 2024

Whereas: State of Nebraska Statutes, sections 39-2302, and 39-2501 through 39-2505 details the requirements that must be met in order for a county to qualify for an annual Incentive Payment; and

Whereas: The State of Nebraska Department of Transportation (NDOT) requires that each county must annually certify (by December 31st each year) the appointment(s) of the County Highway Superintendent(s) to the NDOT using the Year-End Certification of County Highway Superintendent form; and

Whereas: The NDOT requires that such certification shall also include a copy of the documentation of the county highway superintendent's appointment; i.e. meeting minutes showing the appointment of the County Highway Superintendent by their name as it appears on their License (if applicable), their License Number (if applicable), and Class of License (if applicable), the type of appointment, i.e., employed or under contract (consultant, or interlocal agreement with another county and/or incorporated municipality), and the beginning date of the appointment: and

Whereas: The NDOT also requires that such Year-End Certification of County Highway Superintendent form shall be signed by the County Board Chairperson and shall include a copy of a resolution of the County Board authorizing the signing of the Year-End Certification of County Highway Superintendent form by the County Board Chairperson.

Be it resolved that the County Board Chairperson of Burt County is hereby authorized to sign the attached Year-End Certification of County Highway Superintendent form(s).

ROAD REQUEST FROM DECATUR TWP: Ryan Ferguson, Decatur TWP board member, requested opening Co.Rd. 30 to the North to intersect onto Co.Rd. XY. He explained the intersection of Co.Rd. 30 and Hwy. 51 is dangerous and if the requested route could be done, that could divert traffic around to the North then East on to Hwy. 75 thereby avoiding the dangerous intersection on Hwy 51. Chytka, Hwy Supt., reported that County Attorney Talbot told her the northern part of Co.Rd. 30 that runs through section 27 Township 24 range 10E formally known as Public Road #341 is considered 'abandoned' as it has not been in use for 10+ yrs., she also confirmed that this is a Township road. The County Board suggested Decatur TWP get further instructions from County Attorney Talbot since the road is considered as 'abandoned' status.
