Burt County Extension Office:

Angi Heller, Engagement Zone 8 Coordinator & Marina Duarte de Val

(a) 2024 Annual Report: Presented and placed on file.

(b) <u>Extension Board members:</u> appointed for 2025 -Jill Connealy to replace Joan Bucy; Jeff Madsen to replace Graig McElmuray; Dawne Price to replace Audrey Unwin. Appointments were approved upon motion by Swanson, seconded by Kutchera, By Roll Call Vote: Ayes – Swanson, Kutchera, Titus, Pearson, Johnson, Richards and Connealy. Nays- none.

ZONING: Ann Chytka, Zoning Administrator

Lot Split Flowchart and Application: Chytka wanted to make it clear that all new divisions of land in Burt County requires a survey. A flowchart explains the lot split procedures. Also, the lot split application is changing slightly, the signature by the Assessor is going to be removed from the application. The application is posted on the Planning & Zoning webpage, the flowchart is found on the back of the lot split application.

Section 6.15 Solar Energy Conversion Systems: Discussions were held regarding the need to update the County's Solar regulations. The board passed a motion to sign the following directive**; upon motion by Titus, seconded by Swanson, Passed By Roll Call Vote: Ayes – Swanson, Kutchera, Titus, Johnson, Richards and Connealy. Nays - Pearson. **A Directive to the Zoning Administrator to not accept any applications for Conditional Use Permits for Solar Facilities (Solar Farm) in Burt County for 120 days. During which time the Planning Commission will review Section 6.15 Solar Energy Conversion Systems (starting on page 144 of our current regulations). A committee of (3) three Burt County Board members (Jeff Kutchera, Carl Pearson, Paul Richards) shall come up with a suggested list of items within Sec. 6.15 to be reviewed by the Planning Commission.

ROADS: Ann Chytka, Highway Superintendent

Bridge Inspections: Dan Alexander of Midwest Engineering, Inc. reviewed structure summaries and map from inspections completed in 2024.

Engineering: Dan Alexander of Midwest Engineering, Inc. offered engineering services for any Burt County roadway project needs in the future.

Project C-11 (450): Ann stated that she is going to have Midwest Engineering, Inc. help with the upcoming letting of this project.

Library Interlocal Agreement:

Interlocal agreement between Burt County, NE and three (3) Cities (Lyons, Oakland and Tekamah). The County annual donation (\$1,500.00) is to help support the City costs for maintenance, staffing, etc. of City libraries; the City library is a benefit for all citizens of the County. Chairman signed the agreement upon motion by Kutchera and seconded by Titus. Approved By Roll Call Vote: Ayes – Swanson, Kutchera, Titus, Pearson, Johnson, Richards and Connealy. Nays- none.

Board of Equalization:

Richards moved the Board recess at 10:23 AM for *Board of Equalization*, Pearson seconded, motion passed with All Ayes. The Burt County Board of Supervisors reconvened at 10:24 AM upon motion by Richards, seconded by Pearson with All Ayes. See separate minutes for BOE.

Public Comments (3): (1) Donette Jackson, 5000 CoRd. HI, Tekamah- (i) Congratulated Jay Johnson on his first meeting (ii) requesting one meeting a month be held in the evenings. (2) Bill Price, 1615 CoRd. 10, Lyons – (i) thanked board for their work on large turbines (ii) comments on Solar Farm sizes and setbacks. (3) Gregg Smith, 2170 CoRd. 5, Lyons – statement about the board option to stipulate in zoning regs the total number of acres of land for wind projects and solar projects.
